## **TENDER NOTICE**

The Forest, Parks & Wildlife Department Gilgit-Baltistan, intends to procure nursery plants of various species for the FY 2022-23 under the PSDP funded Project titled "10 Billion Tree Tsunami Program Phase-I Up Scaling of Green Pakistan Program (Revised) Revival of Forestry Resources" subject to actual release of funds by the Federal Government. Detailed descriptions, specifications and expected required numbers of plants shall be available in the Bid Document to be provided by this Office. Terms and conditions of the procurement procedure are given below:

- Sealed bids are invited from the financially stable firms registered either with SECP or PEC or District Registrar and having valid Federal Seed Certificate.
- 2. The bidders are not allowed to submit bids in joint venture.
- 3. A minimum of Rs 60 million credit transaction during the last 02 years with minimum of Rs 5.000 million closing balance.
- 4. Certificate for supply of a minimum of 0.300 million plants to Govt./Semi Govt. Organizations/Autonomous bodies during the last three years.
- 5. Bids will be conducted through Single Stage-two Envelope (Most Advantageous Bid) procedures as specified in the Public Procurement Rules (PPRA 2004).
- 6. Formula for most advantageous Bid shall be considered on the basis of 60:40 ratio of Technical Proposal & Financial Bids-details of which is available with the Bid Document.
- 7. Separate Bids are invited for all four territorial Forest Circles i.e. Gilgit, Baltistan, Diamer and Astore.
- 8. Bids should be marked clearly for the desired circle.
- Irrational/below market rates as determined by the Tender Processing Committee, will not be considered and rejected.
- 10. Sealed Bids must be delivered to the office of the Chief Conservator of Forest, Parks and Wildlife GB, River View Road, Chinar Bagh Gilgit at 11:00 am 18th November 2022, which will be opened on the same date at 12:00 pm in presence of the bidders or authorized representatives who choose to attend.
- 11. 5% Bid Security in the form of CDR, Pay Order, Demand Draft, or Banker's Cheque from a Scheduled Bank of Pakistan should be accompanied with the financial proposal.
- 12. For obtaining any further information or clarifications regarding tender, contact the undersigned during office hours on working days.
