**Feasibility Study for the Implementation of Forest Monitoring and Information System (FMIS)**

**Assignment Brief:**

The Forest, Parks & Wildlife Department, Gilgit-Baltistan, a government entity responsible for the conservation, protection & sustainable management of forests, wildlife and allied resources, invites Expressions of Interest (EOI) from consultancy firms/consultants to conduct a Feasibility Study for the Implementation of a Forest Monitoring and Information System (FMIS).

This feasibility study will assess current practices, recommend state-of-the-art tools & technologies and solutions, and prepare a Request for Proposals (RFP) for implementing the FMIS. The system aims to enhance forest management, combat deforestation, prevent illegal logging, real-time forest monitoring, timber smuggling, and automation of all the forest & wildlife related operations.

The selection process will follow the Quality and Cost Based Selection (QCBS) method under the Public Procurement Rules, 2004.

**Scope of Services:**

The selected firm/consultant will:

1. Conduct a detailed feasibility study for the implementation of FMIS, providing multiple solutions compatible to already developed apps and solutions under PMRU Chief Secretary Office, focusing on:

- Management Information System for departmental assets, HR & operations
- AI-based feature detection and land use/cover change detection
- AI-based forest inventories and digital applications for field data collection of forest, wildlife and NTFPs
- Automation of forest working plan operations with timber detection technologies.
- Automation of movable and immovable assets of the department
- Tools for centralized monitoring, e-file, correspondence & reporting.
- Development and installation of apps, solutions and tools for FMIS
- Recommend the latest tools and technologies for the implementation of FMIS.
- Prepare a comprehensive RFP for the implementation of FMIS.
- Provide technical support and consultation during the project implementation.

The available budget for the activity/consultancy services is PKR. 5.00 million.

**Eligibility Criteria:**

The prospective Bidders (individual consulting firms or their consortium, as the case may be) must qualify the eligibility, technical evaluation criteria, and other terms & conditions with supporting documents, where required, as set out in the RFP document.

**Deliverable:**

- Inception report after consultation of field formations on the sketch of MIS & Forest monitoring mechanism
- First draft of complete consultancy report which covers all the items of scope of work
- Final draft of consultancy report
- RFP for procurement and development of apps, tools, solutions & hardware
- Assistance and shortlisting of firms/ contractors for procurement of software and hardware
- Test Run, Demonstration and pilot running of hardware and software
