HIRING OF A CONSULTANT FOR

“AFFORESTATION, REFORESTATION & REVEGETATION (ARR) ON BARREN LANDS IN GILGIT- BALTISTAN”

Assignment Brief:

The Forests, Parks and Wildlife Department, GB (**Procuring Agency**) invites proposals from qualified national & international consulting firms to undertake a carbon feasibility study & implementation planning for an ARR project on barren lands within GB. The consulting firm will be responsible for identifying suitable sites across various districts (e.g. valley slopes, other uncultivated waste lands GIS Polygon available) and formulating a Project Design Document (PDD) for an afforestation /reforestation project that can generate verified carbon credits. The assignment includes baseline assessments of current land use (& carbon stock), projections of carbon sequestration from proposed interventions, stakeholder consultations, Carbon Certification Standards and development of an implementation roadmap.

Scope of Services:

The scope of work for the consulting firm shall include, but not be limited to:

- Inception and Planning
- Site Identification and Baseline Assessment
- Land acquisition and resettlement plan (LARP)
- Environmental and Social Impact Assessment (ESIA)
- Technical Feasibility Study
- Carbon Sequestration Potential Analysis and Carbon Accounting
- Financial & Economic Analysis and Risk Assessment
- Stakeholder Consultation and Institutional Analysis
- Project Design Documentation
- Monitoring and MRV Plan
- Implementation Roadmap based on the feasibility assessment
- Drafting and Finalization of Deliverables with deliver presentations
- Role and Responsibilities of the Consultant in Carbon Asset Management
- Recommended Carbon Certification Standard
- Close coordination during all stages of the contract period

The available budget for the activity/consultancy services is fixed.
